Data Protection Policy

1. Introduction

LG Fire Ltd t/a LG Building Contractors needs to collect and use certain types of information about the Individuals or Service Users who come into contact with the company in order to carry on our work. This personal information must be collected and dealt with appropriately whether is collected on paper, stored in a computer database, or recorded on other material and there are safeguards to ensure this under the General Data Protection Regulation (EU) 2016/679, as adopted into law of the United Kingdom in the Data Protection Act 2018.

2. Data Controller

LG Fire Ltd t/a LG Building Contractors is the Data Controller under the Act, which means that it determines what purposes personal information held, will be used for. It is also responsible for notifying the Information Commissioner of the data it holds or is likely to hold, and the general purposes that this data will be used for.

3. Disclosure

LG Fire Ltd t/a LG Building Contractors may share data with other agencies such as the local authority, funding bodies and other voluntary agencies. LG Fire Ltd t/a LG Building Contractors will not disclose any information to any third party other than these unless written consent is provided by the Individual/Service User/Client.

The Individual/Service User/Client will be made aware in most circumstances how and with whom their information will be shared. There are circumstances where the law allows *LG Fire Ltd* to disclose data (including sensitive data) without the data subject's consent.

These are:

- a) Carrying out a legal duty or as authorised by the Secretary of State
- b) Protecting vital interests of an Individual/Service User/Client or other person
- c) The Individual/Service User/Client has already made the information public
- d) Conducting any legal proceedings, obtaining legal advice or defending any legal rights
- e) Monitoring for equal opportunities purposes i.e. race, disability or religion
- f) Providing a confidential service where the Individual/Service User/Client's consent cannot be obtained or where it is reasonable to proceed without consent: e.g. where we would wish to avoid forcing stressed or ill Individuals/Service Users to provide consent signatures.

LG Fire Ltd t/a LG Building Contractors regards the lawful and correct treatment of personal information as very important to successful working, and to maintaining the confidence of those with whom we deal.

LG Fire Ltd t/a LG Building Contractors intends to ensure that personal information is treated lawfully and correctly.

To this end, *LG Fire Ltd t/a LG Building Contractors* will adhere to the Principles of Data Protection, as detailed in the General Data Protection Regulation (EU) 2016/679, as adopted into law of the United Kingdom in the Data Protection Act 2018.

Specifically, the Principles require that personal information:

- a) Shall be processed fairly and lawfully and, in particular, shall not be processed unless specific conditions are met,
- b) Shall be obtained only for one or more of the purposes specified in the Act, and shall not be processed in any manner incompatible with that purpose or those purposes,
- c) Shall be adequate, relevant and not excessive in relation to those purpose(s)
- d) Shall be accurate and, where necessary, kept up to date,
- e) Shall not be kept for longer than is necessary
- f) Shall be processed in accordance with the rights of data subjects under the Act,
- g) Shall be kept secure by the Data Controller who takes appropriate technical and other measures to prevent unauthorised or unlawful processing or accidental loss or destruction of, or damage to, personal information,
- h) Shall not be transferred to a country or territory outside the European Economic Area unless that country or territory ensures an adequate level of protection for the rights and freedoms of Individuals/Service Users in relation to the processing of personal information.

LG Fire Ltd t/a LG Building Contractors will, through appropriate management and strict application of criteria and controls:

- Observe fully conditions regarding the fair collection and use of information
- Meet its legal obligations to specify the purposes for which information is used
- Collect and process appropriate information, and only to the extent that it is needed to fulfill its operational needs or to comply with any legal requirements
- Ensure the quality of information used
- Ensure that the rights of people about whom information is held, can be fully exercised under the Act. These include:
 - o The right to be informed that processing is being undertaken,
 - o The right of access to one's personal information
 - o The right to prevent processing in certain circumstances and
 - The right to correct, rectify, block or erase information which is regarded as wrong information)
- Take appropriate technical and organizational security measures to safeguard personal information
- Ensure that personal information is not transferred abroad without suitable safeguards
- Treat people justly and fairly whatever their age, religion, disability, gender, sexual orientation or ethnicity when dealing with requests for information
- Set out clear procedures for responding to requests for information

4. Data collection

Informed consent is when

 An Individual/Service User/Client clearly understands why their information is needed, who it will be shared with, the possible consequences of them agreeing or refusing the proposed use of the data and then gives their consent.

LG Fire Ltd t/a LG Building Contractors will ensure that data is collected within the boundaries defined in this policy. This applies to data that is collected in person, or by completing a form. When collecting data, LG Fire Ltd t/a LG Building Contractors will ensure that the Individual/Service User/Client:

- a) Clearly understands why the information is needed
- b) Understands what it will be used for and what the consequences are should the Individual/Service User/Client decide not to give consent to processing
- c) As far as reasonably possible, grants explicit consent, either written or verbal for data to be processed
- d) Is, as far as reasonably practicable, competent enough to give consent and has given so freely without any duress
- e) Has received sufficient information on why their data is needed and how it will be used

Employee data collected can be in the form of personal information for both HR and Payroll purposes and data applicable to the individual's role, such as driving license information or DBS records. This also includes all information held on the company itself and the Directors/Shareholders involved.

Client and Supplier data will also be held which can contain commercial information such as Company details including Director/Shareholder information and Domestic Client information such as personal data in the form of telephone, email and postal addresses.

CCTV is operational 24 hours internally and externally to the building for the sole purpose of security measures for the building and the Company's possessions.

5. Data Storage

Information and records relating to service users will be stored securely and will only be accessible to authorised staff only.

Information will be stored for only as long as it is needed or required statute, which is backed up every night, and will be disposed of appropriately when required.

All data is stored on a centralised cloud server, maintained by our IT company who use firewall and antivirus protection. All server users can only log onto the centralised server by using a password of their choice to exclude unauthorised access and to maintain confidentiality. All portable electronics are password protected.

It is *LG Fire Ltd t/a LG Building Contractors* responsibility to ensure all personal and company data is non-recoverable from any computer system previously used within the organisation, which has been passed on/sold to a third party.

6. Data access and accuracy

All Individuals/Service Users have the right to access the information *LG Fire Ltd t/a LG Building Contractors* holds about them. *LG Fire Ltd t/a LG Building Contractors* will also take reasonable steps ensure that this information is kept up to date by asking data subjects whether there have been any changes.

In addition, *LG Fire Ltd t/a LG Building Contractors* will ensure that:

- It has a Data Protection Officer with specific responsibility for ensuring compliance with Data Protection
- Everyone processing personal information understands that they are contractually responsible for following good data protection practice
- Everyone processing personal information is appropriately trained to do so
- Everyone processing personal information is appropriately supervised
- Anybody wanting to make enquiries about handling personal information knows what to do
- It deals promptly and courteously with any enquiries about handling personal information
- It describes clearly how it handles personal information
- It will regularly review and audit the ways it hold, manage and use personal information
- It regularly assesses and evaluates its methods and performance in relation to handling personal information
- All staff are aware that a breach of the rules and procedures identified in this policy may lead to disciplinary action being taken against them

This policy will be updated as necessary to reflect best practice in data management, security and control and to ensure compliance with any changes or amendments made to the General Data Protection Regulation (EU) 2016/679, as adopted into law of the United Kingdom in the Data Protection Act 2018.

Glossary of Terms

Data Controller – The person who (either alone or with others) decides what personal information *LG Fire Ltd t/a LG Building Contractors* will hold and how it will be held or used.

General Data Protection Regulation (EU) 2016/679, as adopted into law of the United Kingdom in the Data Protection Act 2018 – The UK legislation that provides a framework for responsible behaviour by those using personal information.

Data Protection Officer – The person(s) responsible for ensuring that *LG Fire Ltd t/a LG Building Contractors* follows its data protection policy and complies with the General Data Protection Regulation (EU) 2016/679, as adopted into law of the United Kingdom in the Data Protection Act 2018.

Individual/Service User/Client – The person whose personal information is being held or processed by **LG Fire Ltd t/a LG Building Contractors** for example: a client, an employee, or supporter.

Explicit consent – is a freely given, specific and informed agreement by an Individual/Service User/Client in the processing of personal information about her/him. Explicit consent is needed for processing sensitive data.

Notification – Notifying the Information Commissioner about the data processing activities of *LG Fire Ltd t/a LG Building Contractors*, as certain activities may be exempt from notification.

Information Commissioner – The UK Information Commissioner responsible for implementing and overseeing the General Data Protection Regulation (EU) 2016/679, as adopted into law of the United Kingdom in the Data Protection Act 2018.

Processing – means collecting, amending, handling, storing or disclosing personal information.

Personal Information – Information about living individuals that enables them to be identified – e.g. name and address. It does not apply to information about organisations, companies and agencies but applies to named persons, such as individual volunteers or employees within (GROUP).

Sensitive data – refers to data about:

- Racial or ethnic origin
- Political affiliations
- Religion or similar beliefs
- Trade union membership
- Physical or mental health
- Sexuality
- Criminal record or proceedings
